### DISABILITY BENEFIT FOR MEMBERS

**This is to certify that:** Effective January 1, 2008, all members in good standing of the Michigan Association of Governmental Employees shall be eligible for a **Five Hundred Dollar (\$500) Disability Benefit** after eight (8) consecutive weeks of such disability payable by MAGE. Such Five Hundred (\$500) Dollar payment shall be limited to one payment every two (2) years. When a period of disability extends from one calendar year to the next, this is still considered one period.

To be eligible, a member must have maintained continuous MAGE membership during the six (6) months immediately preceding the injury or illness. The member must also remain in good standing and be current with his/her payment of dues during the period of disability. A member who is not having dues paid through payroll deduction must continue to pay his/her dues directly to MAGE to remain eligible for this disability benefit.

The disability benefit must be claimed by the member by the end of the calendar year following the year that the disability began by filing a claim with MAGE.

Persons who retire or are no longer a member of MAGE are ineligible for the disability benefit.

## Michigan Association of Governmental Employees (MAGE)

### DEATH BENEFIT

**This is to certify that:** Effective January 1, 2008, all members in good standing of MAGE/OPEIU Local 2002 shall be eligible for a **Five Thousand Dollar (\$5,000) Death Benefit** payable by the Office and Professional Employees International Union. A member's good standing and eligibility for this Five Thousand Dollar (\$5,000) benefit is forfeited if the member is more than two (2) months in arrears in dues owed to MAGE/OPEIU Local 2002 during the fourteen (14) month period prior to death, exclusive of the month of death.

A member who does not pay dues through payroll deduction due to leave of absence, disability or other similar circumstances remains eligible for the death benefit if the member keeps his/her dues payments current. Therefore, a member must continue to pay dues directly to MAGE Local 2002 during these periods in order to remain eligible for this benefit.

Persons who retire or are no longer a member of MAGE are ineligible for this death benefit. All benefit claims will be paid in accordance with rules promulgated by OPEIU.

## Michigan Association of Governmental Employees (MAGE)

### ACCIDENTAL DEATH AND DISMEMBERMENT BENEFIT

**This is to certify that:** Effective January 1, 2008, all members in good standing of MAGE/OPEIU Local 2002 shall be eligible for a **Five Thousand (\$5,000) Dollar Accidental Death and Dismemberment Benefit** payable by the Office and Professional Employees International Union. A member's good standing and eligibility for this Accidental Death and Dismemberment Benefit is forfeited if the member is more than two (2) months in arrears in dues owed to MAGE/OPEIU Local 2002 during the fourteen (14) month period prior to accidental death or dismemberment, exclusive of the month of accidental death or dismemberment.

A member who does not pay dues through payroll deduction due to leave of absence, disability or other similar circumstances remains eligible for the accidental death or dismemberment benefit if the member keeps his/her dues payments current. Therefore, a member must continue to pay dues directly to MAGE/OPEIU Local 2002 during these periods to remain eligible for this benefit.

Persons who retire or are no longer a member of MAGE are ineligible for the accidental death and dismemberment benefit. All benefit claims will be paid in accordance with rules promulgated by OPEIU.
